The **Labourer** performs various activities required for the operational, winter and structural maintenance of airport grounds and surfaces, buildings and water and sewer systems.

Job Duties:

Below is an outline of the job's primary duties and requirements, which is not all-inclusive. Incumbent(s) may be expected to perform job-related duties other than those contained in this document and may be required to have specific job-related knowledge and skills.

- Responsible for the upkeep of all green areas around the airport grounds, including mowing grass, trimming hedges, weeding, and maintaining flowers and shrubs.
- Performing general maintenance duties on asphalt and concrete pavement.
- Ensuring the outdoor areas such as walkways, parking lots, and the areas around the terminals are clean and free of debris. This may involve sweeping, raking, and garbage removal.
- Operating light tools and machinery like lawnmowers, leaf blowers, tool cats, skid steer, and other landscaping equipment, including routine maintenance, lubrication, and fueling.
- Clearing snow and ice from walkways, roadways, and emergency exits to ensure safe passage for passengers and staff.
- Assisting with minor repairs and maintenance tasks around the airport property, such as repairing fences, walls, toilets, urinals, and signage.
- Assisting with repairs in operational areas (trades), as directed.
- Attends scheduled safety and operations meetings.
- Responding to questions and complaints from the public.
- Airport parking lot enforcement, issuing tickets, attending court if required.
- Performing emergency intervention duties, as required.
- Adhering to all airport safety and security regulations.
- Monitoring and managing safety around all airport areas.
- Observes safe work methods, using safety equipment and securing worksites from safety hazards as necessary.
- Maintaining essential records of work performed.

- Performing duties and abiding by the requirements outlined in the various airport programs, such as but not limited to:
 - NWRA Airport Safety Program;
 - NWRA Safety Management Systems (SMS);
 - NWRA Wildlife Management Plan;
 - NWRA Foreign Object Debris (FOD) Plan;
 - NWRA Winter Maintenance Plan;
 - NWRA Apron Management Plan;
 - NWRA Reduced Visibility Operation Plan (RVOP);
 - NWRA Airside Vehicle Operation Program (AVOP); and the
 - NWRA Airport Security Program (ASP).

Qualifications:

- Requires strong communication skills, both verbal and written in English, are required.
- Valid Class 5 or 7 Driver's License.
- Basic computer skills and experience with the Microsoft Office Suite.

Physical Requirements:

- This role requires the ability to work in various weather conditions. Activities are carried out regardless of weather or working conditions, within required safety standards.
- This role demands good physical health, including lifting, bending, and extensive walking.

Experience:

- Experience in snow removal operations.
- Experience in grounds maintenance.
- Experience in building maintenance, including preventive and structural tasks.

Hours of Work:

- Up to 40 hours per week.
- Hours of work are scheduled between 00:00 and 24:00, seven days a week, subject to flight times and regulations.
